#### a. Capital Improvement Projects

Eddie will let Board know as soon as she has a deadline from EBMUD for information. Eddie put together initial list but a lot of pending questions due to lack of communication with EBMUD. Eddie is working to get in touch with Joe. Linnea suggests come with perspective list to AGP meeting and then will get feedback about what to cut. Erica recommends that Eddie try to talk in person to Joe before the meeting.

# 6. Potential Tree Clearing Behind Pond Barn

#### Grants

## b. EBMUD Authorization

This was a project proposed by Michael Bowen. Agreement that there was potential benefit from a project like this, but it would have to go through an EBMUD approval process and the work (major tree removal) would require some outside assistance. Agreement that this is worth bringing up with EBMUD at AGU meeting when scheduled.
